Minutes of the Online Board Meeting Feb. 8-20, 2021

'Bout time for a board meeting, dontcha think? I apologize for missing one in January. We've got some issues to discuss now, see below. Not sure yet if we're going to stick to the old fourth-Thursday-everymonth schedule, or just do this as needed. I'm open to thoughts on this...

Old Business/NONE

New Business:

Field Spraying. Thanks to Scott Hudson for looking into this. Scott wrote (in an email), I heard back from Greg at Greenway Spray. He said the cost would be the same this year as it was last. The invoice and map are attached from last year. The application was done in February last year. Do you want to treat this similar to the runway repair, in that it was voted on and approved, and therefore is an ongoing expense, or do you think it should be voted on annually?" So that's the question. Is this an ongoing expense that can be approved by the board, or do we have to go through the whole club voting process?

New Event Proposal. From Jess Walls:

I'd like to add a glider fun fly May 1st, 2nd, or 9th. Field closed except for gliders and powered sailplanes. "In a follow-up email, Jess added, "The idea was actually Jerry's" He came to me because I'm more of a glider guy than he is.

The date is a problem. April is busy and June is even busier. July is getting too hot. August is too hot and too smokey. How about April 3rd or 4th? Either day is OK with me.

We shouldn't tie up the field both days this first time. If we get a bunch of people (over 20?) then maybe next year we can do 2 days. Maybe have events and winch launches, etc. that would be fun!

Rockets impact our calendar more than any other single type of event. Maybe we should discourage them from taking a Saturday out of our busiest time of the year? At least for events they are not compatible with.

Since our calendar is shared with other clubs, doesn't that automatically make it invitational? An AMA sanction only helps if the event is a rule book type, right? But we could advertise it in the magazine if it is popular this year. Shouldn't this be sent to all Board members? Who decides what event calendar goes to the Board for approval by the membership?"

There's been a bit of discussion already, so now let's make if official. What are your thoughts on adding events to our calendar, what do you think of Jess's idea and proposed date?/

Field Spraying: Personally I feel this should be an annual expense. Whether it's done professionally or by club members, it does need to be done on an annual basis. As previously discussed when approved, our members aren't getting any younger, and frankly shouldn't be asked to handle dangerous chemicals. In hind site, I wish I would have included wording in the original proposal that would have made it's ongoing necessity more clear. If we were meeting as a club it would be easy to bring up and talk about. But considering the struggles of getting business done, I would think the majority of membership would trust the board to make the right decisions on their behalf. All that said, I support having it done as an ongoing expense. If there is any negative feedback or member concern, it can be noted and brought up again next year. My 2 cents.

New Event Proposal: Until we can meet again in a general meeting, I feel the board should discuss and approve any new additions to the event calendar. As I've mentioned already to some of you, I would support a single day sail plane event. But I'm biased as I've recently started getting more into sail planes, so that should be considered with my opinion. I think May is too busy with something going on most weekends. April is definitely better, with only two current events scheduled, one of which is a single day event (Winter Build Challenge), as the sail plane day would be (so the entire weekend isn't closed). I would say April 2nd or 3rd would be better than May as discussed. Personally I would say the 3rd, but only because I'm scheduled to cover at work on the 2nd, and would love to participate:-) .Selfish I know... So either Sat or Sun 2nd or 3rd I would support.

I'm not sure if I agree that rockets impact our calendar more than anything else, as was stated. Most weekend we coexist just fine and even hold our pylon races on same dates as rockets. But I do feel as though they have benefited from our original generosity. Some have suggested that we ask the entire rocket group to become members, rather than just a key individual or two. The possible unforeseen consequence to that is them having as much right to be there any or all days they choose.

- 2. I make a motion to put Jess' idea of a glider event / April 3 or 4 on the calendar.
- 3. I make a motion to mark the parking spaces in front of the covered work area as noted previously by Rob Merriman.

Rob's quote: "I would like to suggest the club lays out chalk striping to designate official parking spots in front of the covered work area. This will maximize the number of vehicles that can have closer access to loading and unloading. I suggest using chalk!"

After discussion with Rob this past week, we realized that chalk wouldn't last long and that spray painting the lines a few times a year would probably be a better idea.

Eric, et al, It sounds as though you misunderstood my e-mail. Since the Board is allowed to authorize up to \$300 over any normal operating expense, until the spraying goes way up in price we just agree on scheduling it. As far as the striping, we can get a decent striping cart (spray can type) and paint for less than \$100. If the Board wants to go this way, I will volunteer to do the striping.

Treasurer Reports

Art Kelly / Wed. Feb. 17

Gentlemen,

My apologies for the delay in getting this out. I had intended to distribute it a couple of days ago but I found that I am a member of that portion of the population who got popped by the second dose of the vaccine. Attached are reports of information that I'll be tracking from month to month.

The first report presents income/expense and membership trendlines from the last several years. Several notes:

- 1. Member Dues are dropping year over year.
- 2. Total Revenues have had cycles but are dropping
- 3. Total Expenses dropped in 2018 but have climbed last two years.
- 4. Membership is dropping and this year's renewal rate is discouraging. There has been a tendency to not push renewals until the flying season picks up. This makes if very difficult to do any revenue/expense planning. I recommend that we adopt a policy that dues must be paid by end January or members will be dropped from the roles.

The second report displays performance through January against a benchmark of last year's income and expenses. We are anticipating a spraying expense of \$2500 +/-. That's barely covered by our current dues renewals. While it's true that we have adequate funds in the major expense account the picture doesn't project any possibility of replenishing the account unless revenues are increased or expenses reduced.

This is worthy of additional discussion.

Hi Art, This is good info. It's nice to see the trends. I do wonder about the total paying members that your chart shows. These member numbers didn't look like what I've been seeing the past couple years, so I went back and reviewed rosters on or around the same dates as mentioned. For example; 12/2020 shows 98 paying members in your pdf. While looking at our roster on around that date (November 20) I see 155 members, with 23 who didn't renew, and 4 lifetime. So according to the roster there would have been 128 paid memberships in 2020.

Similar for 2019. The roster shows 166 members with 149 paid for the year vs 119. I guess I don't expect the roster to be 100% accurate, but always assumed the member numbers and renewals were close.
