Minutes

Treasurer's Report

Jay recognized and extended congratulations to Clark and his crew for the great job of cleaning, sanitizing, and installing shelves in the Connex.

Indoor Flying Report

Jerry Stinson reported regarding money needed to rent the gym. The costs are for damage waiver, off site insurance, room rent etc. Discussion followed. Larry Cogdell made a motion second by Rich Josephson, for the club to pay \$85 Annual site rider fee. The Club would also put down the initial security deposit of \$100 (To be replace by whoever is responsible for damage thereafter). Club membership required to fly. Rogue Eagles members pay \$5 each to fly. The vote was unanimous in favor. The first Indoor Fly is scheduled for January 13, 6pm – 8pm at McLoughlin Middle School. 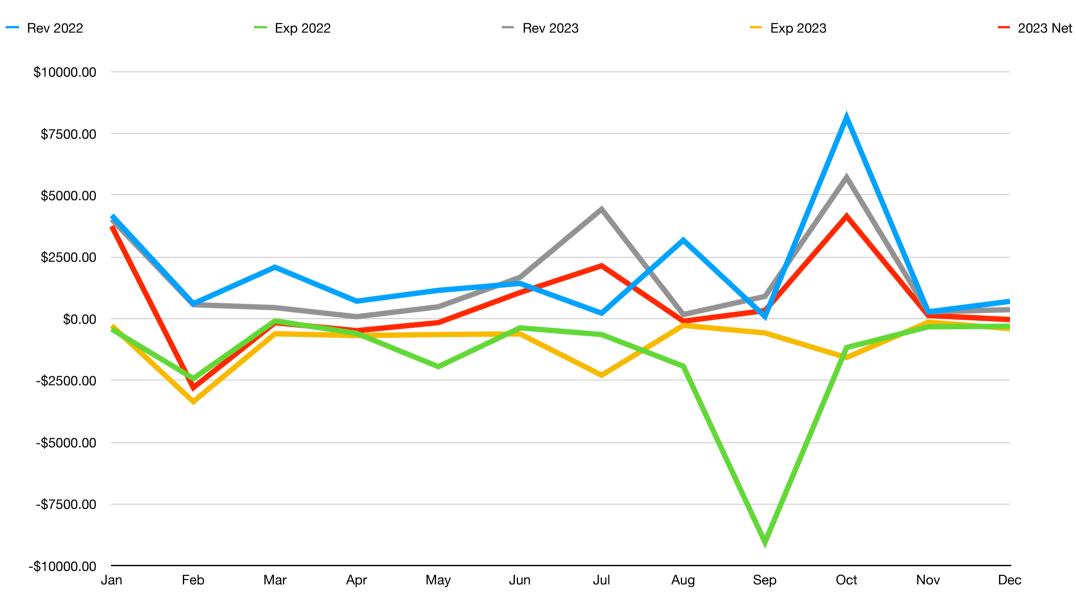

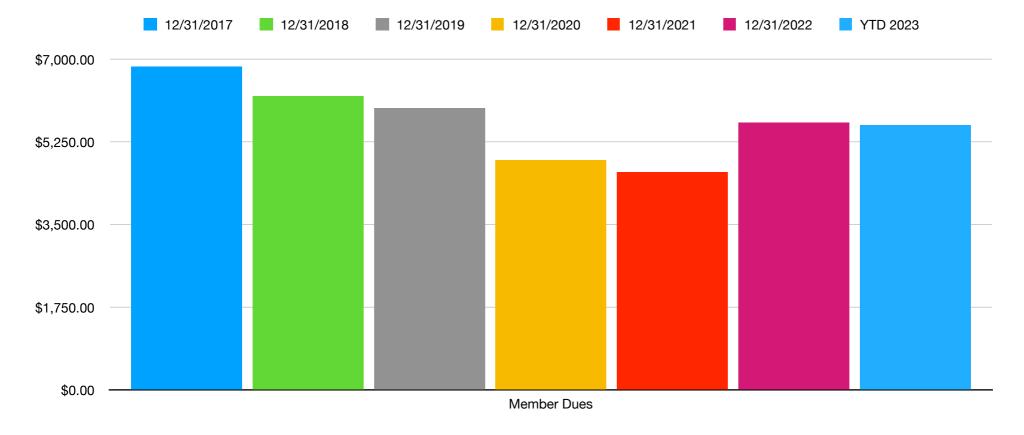
