50/50 Drawing

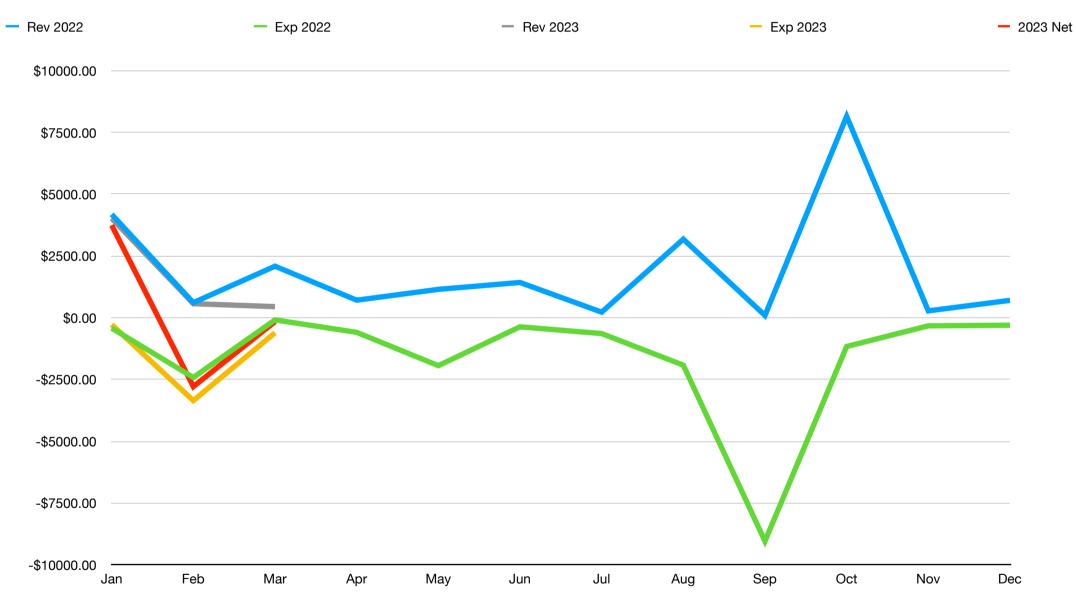
Dave Norton won the drawing. Dave donated all his \$25 winnings back to the club. Thanks Dave.

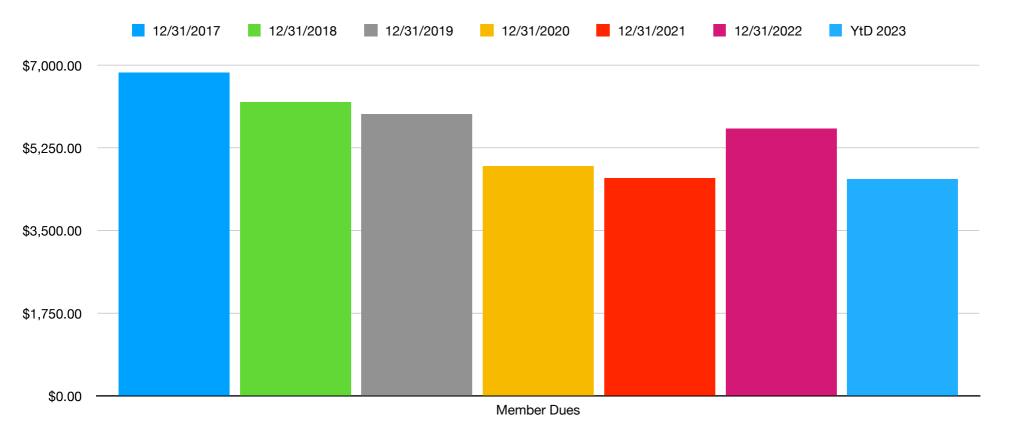
