Board Meeting Minutes Feb 22nd, 2011

Opening:

The meeting was formally opened for business at 7.02 p.m. at the Central Point Senior Center by the President, Joe DeAscentis. There were twelve members present.

Meeting Minutes:

It was decided to omit the reading of the minutes at this meeting.

Treasurer's report.

Ruthie announced that the Share account stands at \$25-77. The Money Maker is currently \$2,342.87. The Checking account is \$8,467.83. This brings the total to \$10,836.47

Runway surface.

Joe reported that a meeting was held at he field with Bill Schoenlieber of Pacific Paving, Ron Kelso and others, to examine the runway condition. Bill commented that the Asphalt was generally in good condition for its age. To fill the cracks, the best method is to force down a mixture of "high quality dry sand and cement". A price quotation for this potential work will be forthcoming. It would be nice to add a "one-inch thick overlay of asphalt". Bill will also quote for this. Extensions to the runway were discussed. Bill will also provide a separate quote for this. Bill stated that his price quotes would be just for the materials. He is not seeking a profit from the work.

Cracks continually appear in asphalt surfaces due to heat expansion and contraction. This can be avoided by cutting slots in the surface at regular intervals.

New event proposal.

The "Oregon Extreme Freestyle Fun Fly" event, proposed by Steve Coleman was briefly discussed by the Board and received final approval to be added to the calendar of events.

Charitable contributions.

The Secretary will dig further back in time in the meeting minutes to find what was decided for the level of "charitable contributions"

Updated Byelaws.

The byelaws document has been updated as agreed at the last meeting. Distribution will be via the "web site" and the "newsletter".

Spring Prep

It has been a long winter for some of us. We have cleaned our models and engines and checked all the electronics. But now that the equipment has been sitting for three months, it needs a little late-winter refresh.

What am I talking about? Battery cycling. If you are using Nicad or NiMH cells, you will need to recharge the batteries about now. These batteries tend to self-discharge over time.

This is also a good time to cycle the batteries and ensure that they still have the capacity to be viable for the coming flying season, or order new batteries if they are of diminished capacity.

Now, if you are using Li-Poly cells, you don't need to charge or cycle the batteries. However, you should check the voltage to make sure they have held the storage charge you gave them. You do bring the cells to the recommended storage voltage, don't you? Yeah, me neither. Well, I will be doing that soon since I bought a charger that can put a storage charge on a Li-Poly.

Oh, and while you're at it, go through your field box. Dump everything out and purge stuff you don't need. Put the paint stirrers (broken propellers) in a container for later use, or just throw them out if you have too many already.

Check your starting and glow batteries and charge them, too. If you have a power panel, remove it and inspect all the wiring. If you keep repair tools in the field box, make sure they are fresh (glue, fuel tubing, rubber bands, band aids, dressings, ointments [for the other guy, of course], etc.) While you're at it get some fresh cleaning solution and paper towels too. Now, when the weather turns fair, you are ready to grab your stuff and go flying. end






