Babe Caltabiano showed us his newly finished "Mickey Moustang" pylon racer with a YS 155 four stroke engine sporting a 13 x 13 pitch fiberglass prop. Babe built a new thinner wing which reduces resistance and reduced weight by $\frac{1}{4}$ Lb. Total weight is 7 Lbs. He hopes to start racing with it in events this year in California.

Phil Baehne showed us his new attractive "Top Cat" self designed "wood built" and WWII themed model in two tone Navy colors with a 2 stroke engine and 4ft. wingspan... maiden flight coming up.

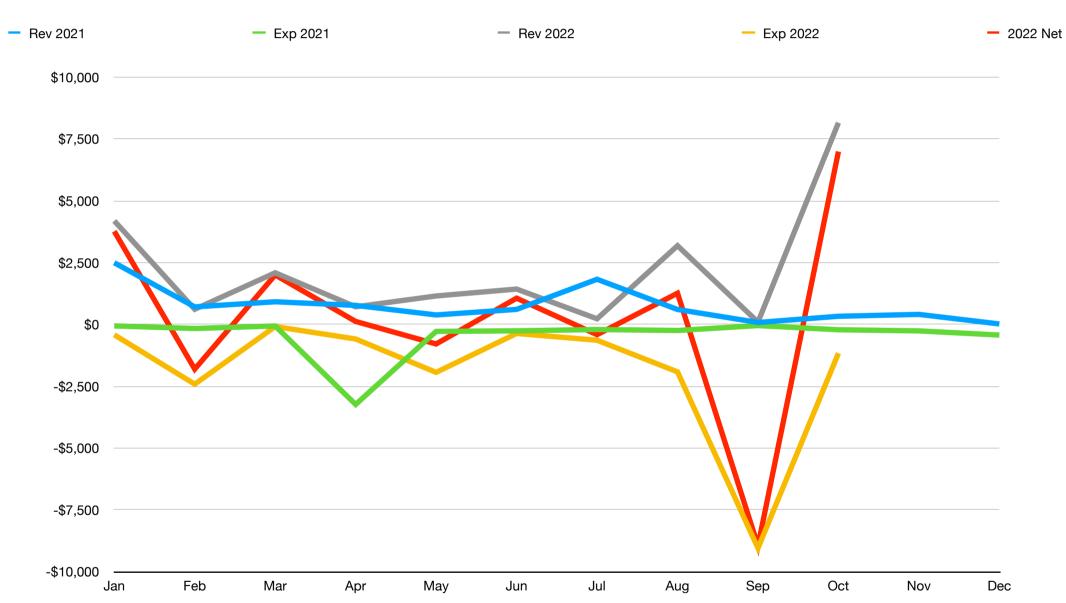

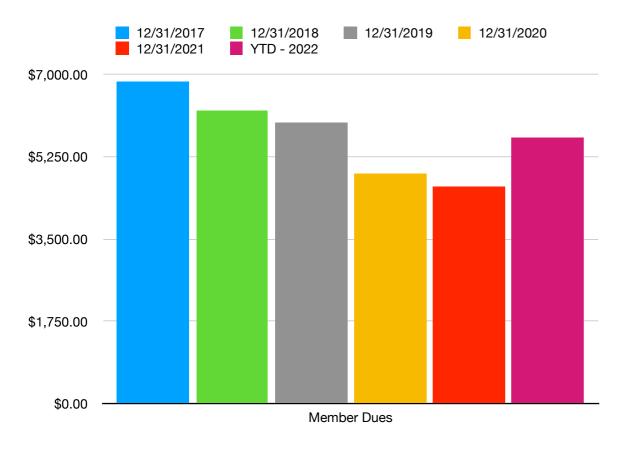
