Board Meeting Minutes January 25, 2011

Opening:

The meeting was formally opened for business at 7.05 p.m. at the Central Point Senior Center by the President, Joe DeAscentis. There were sixteen members present.

Meeting Minutes:

The minutes of the January 11th. General meeting, prepared by Wray Freitas, were read by the Secretary. A correction was moved by Joe. It was recorded that Jay Strickland was the close friend of Pacific Asphalt. This is incorrect and the proper person is actually Ron Kelso. A motion was moved seconded and approved to accept the minutes as amended.

Joe reported that he and Ruthie Beck had been along to the Rogue Federal Credit Union to have the names for the accounts formally changed. Ruthie is in the process of taking the treasury over but is currently fighting some computer problems.

Joe announced the names for the new Officers and contributors:

Bill Grove stated that he is willing to continue helping with Flight Instructing.

Joe mentioned that there are a couple of Job Descriptions missing in the Membership Manual that are needed. Namely, for Safety Co-coordinator, Newsletter Editor, Members-at-large and Flight Instructor. Joe and Rick Lindsey have composed the descriptions and Joe read them out loud to the meeting and invited any additions or changes. A motion was moved seconded and approval was given to add these new Job Descriptions into the Membership Manual.

Joe reminded everyone that safety is everybody's responsibility so we should all watch out for unsafe practices and help out the offender, but do it in a friendly, civil and sensible manner. There is no need for any bad feelings or aggression.

New event proposal.

Steve Coleman addressed the meeting and presented his proposal to add a new event to the 2011 calendar. This is for a Free Style 3D flying competition. He outlined the potential costs, income and benefits that would likely ensue to the club. Jeff Jarvis would be the C.D. There was some discussion on this and what dates might be possible. The Board tabled the topic for further discussion and consideration.

Charitable contributions.

Joe talked briefly about the policy of the club regarding charitable contributions. Donations levels will be determined beforehand. When final revenues have been received, then it will be simple to calculate what dollar amount will be contributed. There will then be no need for further debate later about what level a contribution should be.

Neighboring club events.

Our "events calendar" has other club events listed in addition to our own. The Board does not consider the clubs to be in competition or that other club events should be excluded for any reason. The Rogue Eagles Events Co-coordinator and Webmaster will list all events that they deem appropriate according to this policy.

Runway surface.

There was an extended discussion about the state of the runway and cracks, past history and the merits of the various types of surface and work involved to repair. Joe will be meeting with a professional asphalt surfacing professional to investigate our possible options going forward to repair the runway.

Lake Selmac 2011.

The Rogue Eagles will be partnering again with the Rogue Valley Flyers to conduct the float fly. Joe requested names of people from our club who will definitely commit to provide manual assistance in the setup, teardown etc. for the event. Several hands were raised to volunteer this help.

R.E. Swap Meet.

The event last year held on September 18th was severely dampened by rain. Figuratively and literally. Joe suggested that we move the date forward so that we might enjoy better weather for the 2011 event. Presently it is scheduled for September 17th. After some discussion it was rescheduled to May 7th.

Flightmasters Potluck.

Rick Lindsey announced that we have again been invited to participate in the Flightmasters BBQ and Fun Fly in Keno on June 26th. Several people mentioned what a great field they have there and how well they treat R.E. members who show up. The event is very highly recommended. Rick is going to reciprocate and extend invitations back to their club to join our "pot luck" events.

Pattern Primer

Rick Lindsey stated that Rex Lescher (?) has proposed to run a "pattern primer" event the week before the N.S.R.C.A. F3A contest on June 10-12. i.e. June 4th for the primer. The intent is to introduce as many people as possible in pattern flying and get them interested in participating /competing. It would not involve shutting down the field for regular flying. A motion was moved, seconded and approved for Rick to proceed in scheduling the primer event.

Meeting frequency.

Alan Littlewood has proposed that we try to make the Board meetings more efficient and businesslike, with a couple of suggested options for reducing the meeting frequency to a level that is necessary to conduct business, but not excessive in terms of time and cost for the Board members. Currently it is impossible to get all the Board members together to the meetings. There was an extended discussion on this topic and there are some genuine issues and logistics involved to make any change. Joe is going to do some checking with the management of the Senior Center to see if there are any problems with us adjusting the Board meeting schedule. A motion was moved seconded and approved for the Board to proceed with investigating the possibility of adjusting the meeting schedule.

Pending By-Laws change.



Safety Tip

Before you start your RC heli or airplane: Turn your transmitter <u>on first, aircraft on second</u>. Never turn your RC airplane or helicopter on with your transmitter off. Another transmitter in the area may take over and fly your airplane or helicopter into a tree, a power line, or right into the ground.

After you land: Aircraft off first, transmitter off second. Never turn your transmitter off with your plane or helicopter on. Stray signals from other transmitter can, and most likely will, take control of your airplane or helicopter.

PBY Catalina

With over 4000 PBY's produced during WW2 the PBY became a familiar sight to servicemen in all theaters of action especially the pacific.

Originally intended as a patrol bomber, the "cat", as it was often called, served many duties for which it was not intended such as: anti submarine warfare, maritime patrol, convoy escorts, cargo transport, night attack and naval interdiction but the most famous duty it performed was as a search and recue aircraft picking up downed aircrews and naval personnel. Thousands of servicemen owe their lives to the Cat.
